**Spring Term 2024 Textbook Rental Agreement**

You (the student) have entered into a rental agreement with the Inver Hills Community College Bookstore to *loan* you one copy of each selected rental title. Rental textbooks are the intellectual property of the author(s) and are copyrighted by the author(s) and/or publishers. Textbook rentals are not to be reproduced. The rental agreement is only effective for the current term. Per this agreement, you are responsible for the following:

**-I understand that titles I rent are and remain the property of the Bookstore.**

-Materials must be returned at the end of the term in the appropriate condition: clean, no extensive highlighting or notes, and *without damage*. The Bookstore or its representatives will make the final determination of book condition.

-All components must be returned. If a component is missing, I understand the materials are non-returnable.

-I understand I will be billed an additional cost equal to the FULL RETAIL price of the materials if any items/components are damaged or missing.

***-Rentals must be returned to the bookstore before 4:00pm on Friday, May 10, 2024.***

**-I understand I will be billed the difference between the rental price of the book and the retail price PLUS a non-return fee of \$25.00 per book if they are not returned by 4:00pm on Friday, May 10, 2024.**

(Example: FULL RETAIL=\$100.00, Rental Fee=\$50.00. You will be billed  $\$50.00 + \$25.00 = \$75.00$ . *The rental fee is NOT taken off of the bill, so your actual book cost is \$125.00).*

**\*PLEASE NOTE: DO NOT sell your rentals! If you sell your rental books at the in-store or online buyback, the book will be treated as a non-returned book.**
